I understand and agree that any alcohol, drugs, or dangerous items found in my possession or under my control may be confiscated and discarded or destroyed;

_____ 5. I understand and agree that the consequences for violating any of the above include isolation from the activities of the Event and/or removal from the Event;

_____ 6. I understand that the transportation to and from the Event is by NMUSD bus only. The use of private cars will not be allowed;

PARENT CONTRACT

_____ I, THE UNDERSIGNED PARENT OR LEGAL GUARDIAN OF _____
(my son/daughter's name) do give permission to attend the Corona del Mar High School PTA Grad Night 2018
Event (the Event) on June 21st-22nd, 2018.

_____ I understand that attendance at the Event is purely voluntary and a privilege and as a condition of attending the Event, my child may not be under the influence of, or in the possession or control of any alcohol or other mind-altering substances at any time immediately before or during the Event. Also, my child may not engage in any behavior that threatens the safety and/or security of the Event or is otherwise disrespectful toward any person or property and may not have in his/her possession any weapons or dangerous items. I understand that violation of any of these conditions may be determined by a representative of the Grad Night venue or a PTA parent chaperone present at the Event in his/her sole discretion and may result in my son/daughter being removed from the Event.

_____ Further, I understand that my child's personal articles may be searched at any time immediately before or during the Event by professional security personnel or PTA parent chaperone. In the event any disallowed substance and/or items are found, such items will be confiscated and may be discarded or destroyed.

_____ I understand that my child will be transported to and from the event by way of NMUSD bus. Transportation by private car will not be allowed. I understand that my child may engage in physical activities while at the Event. Consequently, I understand there are inherent risks associated with attending the Event and further, that my child's attendance is conditioned upon his/her assuming responsibility for those risks. I represent that to the best of my knowledge, my child is in generally good health and able to participate in the Event without endangering his/her health and/or safety. In the event my son/daughter suffers any illness or accident while attending the Event, I consent to the administration of emergency medical treatment.

_____ I hereby release Corona del Mar High School PTA and each and every unit and level of PTA and each of their respective directors, officers, agents, employees, members, volunteers, affiliates, representatives, attorneys, insurers, successors, and assigns from any and all rights, claims, demands, obligations duties, liabilities and/or cause of action, of any kind or nature whatsoever, including but not limited to, claims for personal injury and/or property damage, which my child and/or I may have now or in the future by reason of any matter or thing arising directly or indirectly out of the Event.
